This is the day that the Lord has made, let us rejoice and be glad in it. I stand before you for the third opportunity of my tenure as your 19th Most Worship Grand Master of the Most Worshipful Prince Hall Grand Lodge of Georgia. I would like to thank each member again for the opportunity to serve. I will present the

status of Prince Hall Masonry, in Georgia, the state of our nation, and its impacts on our organization as well as my stewardship. God has shown you, what is good, and what does the Lord require of you? "To act justly and to love faithfulness and to walk humbly with your God."

To the officers, thank you for supporting me as we continue to fulfill my vision for this jurisdiction. Let us not forget those who made a path for us to follow. The remarkable success of this Jurisdiction is, because of trusting in the lord and in his holy name for he has not failed us yet. Over the last two years we have faced many challenges, but through all our ups and downs we made it though, for that I say thank you. Before I continue, let us not take on such an important undertaking, without first invoking the blessings of the deity. I would like to ask Rev. Porter Denson, Jr., to come in his own way and lead us to the throne of grace, mercy, and prayer.

NECROLOGY:

The Grand Architect of the Universe has allowed us to assemble once again at another Grand Session. Unfortunately, there are so many brothers and sisters who were present last year who are no longer with us. Since we last met, in June 2024, lodges have reported eighty brothers who have departed from this earth. Those names were called on Tuesday at the Lodge of Sorrow. Words will never express the emptiness this Jurisdiction has suffered in the loss of our membership.

CONDITION OF THE STATE

The Condition of our beloved state of Georgia is at a critical crossroad where policy, equity and leadership must come together to serve all, not just a privileged few. Far too many of our underserved communities and seniors continue to fall through the cracks of a healthcare system that remains out of reach, either due to cost, access, or policy neglect. Healthcare should not be a privilege base on zip code or income level; it is a human right, and Georgia must do better to expand coverage. In education we face widening achievement gaps, overwork teachers, and underfunded schools, especially in historically Black communities. Our children deserve more than promises; they deserve action that equips every classroom with the tools to prepare the next generation for success in a rapidly changing world. We must champion policies that invest in early childhood education, raise teachers' pay and ensure equal access to quality education, from urban centers to rural districts. We will never advance as a state while ignoring those most in need. Our state continues to have devastating weather in some locations. Governor Kemp signs the fiscal year 2024-2025 budget during a ceremony inside the Georgia State Capitol. Allocated in the budget was a pay increase for K-12 certified teachers, law enforcement and child welfare workers.

STATE OF THE NATION:

This year our Nation witnessed the installation of a new/former President of the United States. This new Commander in Chief not

only changed the course of our daily lives; it has shaped our immediate future. Nationally, we see a nation of promise tested during challenging times, our economy continues to be uncertain, Inflation, affordable housing and access to reasonable employment remain out of reach for many, especially in communities of color. We continue to witness the gap between wealth and poverty, and generational advancement remains a struggle for many. We have witnessed the sudden closure of Federal jobs, also in devastation the horrific removal of human beings shackled in chains and sent back to their previous Country without due process all by the stroke of a pen. This comes from the President of the United States of America, who took an oath with his hand on the bible to uphold the Constitution of the United State of America. He is only concerned with pardoning criminals that he feels the system has failed.

In healthcare we have witnessed families without adequate insurance. Mental health care, especially for our youth, is a crisis we can no longer afford to overlook.

Our public education system, long held the ladder to upward mobility, faces challenges of bias, funding, and students and teachers alike are navigating uncertainty, and our charge is to support them through mentorship, and the building of systems that uplift, not divide. We have seen investment in foundations, yet it has not always reached neighborhoods and counties where it is needed most. Roads, schools, hospitals, broadband, these must be accessible to all Americans, not a privileged few. Our

democracy is strained. Voter suppression and political misinformation threaten the foundation we hold dear. But we as citizens and as Masons, must remain committed by truth, justice, and the sacred power of the vote.

STATE OF THE CRAFT:

Thanks to each of you, I am pleased with the condition of the craft. Yes, we still have those who are selfish and negative and continue to cause confusion among the craft. Some of us are misusing the ballot box and turning our heads for our friends. Just because someone is your good friend, does not make him a good mason. There is no way to do wrong right, but it is always the right time to do the right thing.

Each year I stand before you and tell you the Jurisdiction is in order; this year is no difference. It is one of my duties as Grand Master to make sure that all Masonic Houses in this jurisdiction that are part of the Prince Hall family achieve status and recognition as we travel through the world. Brothers, at some point we must stop complaining and support the plans we have in place. We must do a better job in taking care of our gold cards and life members.

We must continue to increase our membership and accept changes if we want this organization to live on. As Prince Hall Masons it is our time to bat, we must step to the plate and take a more active roll in our community, the economy, and the welfare of does who need our help because no man is in island, no man stands alone. However, peace and harmony shall and will prevail in the jurisdiction of Georgia.

KOP:

I would like to thank Brother Aldric Little and all the committee members for the growth and the development of our young men. Once again, this Grand Lodge supports your summer camps and all your state obligations. The Knights of Pythagoras have completed a successful year of meeting their goals. They have set the standards high in ensuring that every young man in the group gets the much-needed attention and focus on making sure they stay focused on their education, moral standings, and goals they have set for their lives. We now have nine active councils in our Jurisdiction and looking forward to increasing that number by at least three more by reactivating councils in the year 2025. Brother Little has instituted quarterly meetings and training with directors and brothers who work with our program to ensure that we are meeting the standards, of the national outlined program consistent throughout the State. Recently, I was appointed Chairperson of the COGM Membership Committee and to the KOP COGM mentoring Committee.

SOUTHERN REGION CONFERENCE OF GRAND MASTER:

I attended the Southeastern Region Conference of Grand Masters, which was held in Birmingham, Alabama at the Hyatt Regency Hotel. The Honorable Corey, Hawkins, Sr, was the host Grand Master. It was a good meeting, where peace and harmony prevailed. There were 10 Jurisdictions present, totally 73

brothers from the following Jurisdictions: Alabama, Arkansas, Bahamas, Caribbean, Forida, Georgia, Mississippi Oklahoma, Tennessee, Texas. PGM Lester Arnold of the Caribbean who was among us has since passed away.

Each Grand Master introduced members present from their jurisdiction. There were some visiting guests to include the Conference of Grand Masters President, MWPGM Eugene Anderson of Indiana, and the Conference of Grand Masters Executive Secretary, Emmanuel Stanley of Maryland. The annual election was held, and all officers remained the same.

CONFERENCE OF GRANDMASTER (COGM):

I attended the Conference of Grand Masters, which was held in Omaha, Nebraska May $15^{th} - 17th$, 2025. Georgia had great representation. It would be nice to see how some of the Grand Master's deal with some of the same issues we have in our jurisdiction.

We are all Prince Hall Masons. As I travel things are done differently jurisdiction to jurisdiction. This is an opportunity for jurisdictions to come together to discuss issues they may have and share information within their jurisdiction. There seems to be some communication issues with the Prince Hall Shriners. The Ad/Hoc committee made a mission statement that we must establish a meaningful commitment to having some honest dialogue on both the Prince Hall Shriners side and the COGM side.

An election was held, and all officers remained the same. The 2025 Conference of Grand Masters will be in Schaumburg,

Illinois. I would like to thank President PGM Eugene Anderson and his elected officers, and MWPHGM HON Percy Newton Jurisdiction of Nebraska for being an outstanding host.
