THIS VENDOR/LICENSEE AGREEMENT (“Agreement) between the Prince Hall Grand Lodge of Georgia and its Jurisdiction and _____ Business Name, and organized and existing under the laws of _____ Specify State and having its principal place of business at _____ Street Address, _____ City _____ State _____ Zip Code.

The Prince Hall Grand Lodge of Georgia and its Jurisdiction registered and unregistered are protected by Federal law, common law, and the laws of the State of Georgia. The Vendor desires, and the Prince Hall Grand Lodge of Georgia is willing to grant, a license to Licensee to use those of its Marks that are depicted in the attached documents on merchandise that is to be designed, manufactured and/or sold by Licensee (Mark-Bearing Merchandise”) provided that Licensee shall confine its sales of such Mark-Bearing Merchandise as agreed upon with both parties.

THEREFORE, in consideration of the promises and covenants contained herein and for other good and valuable consideration, the Parties, intending to be bound legally, agree to the follows:

_____ Vendor/Licensee is limited to a confined space of 10' x 10' at designated Vending Opportunity for a fee of \$150.00 for a single booth to include an 8-foot table, 2 chairs and trash can at The Classic Center.

_____ Vendor/Licensee may select a confined two-booth space or 10' x 20' with the fee of \$275.00 to include an 8-foot table, 2 chairs and trash can at The Classic Center.

_____ Vendor/Licensee may select a confined three-booth space or 10' x 30' with the fee of \$400.00 to include an 8-foot table, 2 chairs and trash can at The Classic Center.

_____ ADDITIONAL TABLES, CHAIRS, AND POWER HOOK-UPS MUST BE PURCHASED FROM THE HOST VENUE AT LEAST TWO (2) WEEKS PRIOR TO THE EVENT. VENDOR/LICENSEE MUST CONTACT THE VENUE DIRECTLY.

Limitations on Sales

Vendor/Licensee is authorized to sell Mark-Bearing Merchandise, subject to the restrictions and conditions imposed by the Prince Hall Grand Lodge of Georgia which Vendor/Licensee expressly acknowledges and agrees to, including restrictions stated fourth WHEREAS paragraph of this Agreement and the restrictions stated by Prince Hall Grand Lodge of Georgia.

Quality Control and Maintenance

Maintenance of Standards: Prince Hall Grand Lodge of Georgia shall have the right to require the Vendor/Licensee to submit samples of its Merchandise as well as display and packaging materials for Prince Hall Grand Lodge of Georgia's inspection.

RIGHTS RESERVED BY PRINCE HALL GRAND LODGE OF GEORGIA

Licensee acknowledges the Prince Hall Grand Lodge of Georgia's right to undertake actions it deems appropriate to protect its Marks, including the right:

- 1) To restrict or prohibit any Licensee activity deemed by Prince Hall Grand Lodge to be an unauthorized use of a Mark hereunder, which includes any failure by Licensee to conform to the Prince Hall Grand Lodge of Georgia's requirements or standards prescribed hereunder in Licensee's design, manufacturing, advertising, packaging, marketing, promotion, display delivery, distribution or sale of Mark-Bearing Merchandise.
- 2) To deny Vendor/Licensee an Agreement based on Conduct unbecoming of a professional businessperson or conduct that denigrates the attendees of our convention.
